

BROWNES VENTURES LTD T/A BROWNES BOOT CAMP (BBC) TERMS & CONDITIONS:

All BBC Members and visitors to a BBC site, whether in the U.K. or abroad, are required to comply fully with these Terms and Conditions. These terms constitute an integral part of a Member's Contract and are essential for safeguarding the health and safety of our Members, ensuring the continued use of our training sites, and protecting our business interests.

Any individual found to be in non-compliance with these Terms & Conditions upon entering a BBC site may be denied access, removed from the site, or have their membership suspended or terminated at the sole discretion of BBC.

BBC Terms and Conditions are available upon request and on our website. We reserve the right to amend or update them at any time. Notification of any such amendments or updates will be displayed on the BBC website and BBC social media channels.

MEMBERSHIP:

1. Application for membership is subject to the sole discretion of the BBC and its Staff.
2. Applicants must be 16 years of age or over. Individuals under this age are eligible to attend provided a parental/guardian consent form has been signed and presented to the BBC trainer on site.
3. Membership confers the right to use our Sites and equipment, which may vary from time to time. Each membership category is subject to specific restrictions, details of which are provided on our website. Please refer to our website for information regarding any applicable restrictions.
4. Should your membership be terminated by BBC, you will be prohibited from entering any BBC site or using any BBC equipment. Your Membership Card MUST be returned to a BBC Trainer. For this purpose, BBC will communicate such Member's personal data, and the reason for termination, to other Sites as may be necessary for the administration of this Rule.

SITE RULES

1. The wearing of BBC Tops is encouraged at all times during training sessions.
2. BBC requires all members to demonstrate mutual respect for fellow BBC members and BBC staff at all times. Should you have a specific complaint, please direct it to the Managing Director, Angus Browne, at membership@brownesbootcamp.co.uk.
3. BBC accepts no responsibility for lost, damaged, or stolen property whilst training and is not accountable for the personal belongings of members or visitors.
4. All Members must show respect for the surrounding neighbourhood and training site, and are required to remove all litter upon departure.

DIRECT DEBIT:

To avail yourself of the discounted membership, you must agree to the following Terms and Conditions. Please note that by agreeing to these Terms and Conditions, you will be applying for and entering into a legally binding contract with Brownes Boot Camp.

The following specific Terms and Conditions must be complied with at all times and constitute an integral part of your contractual agreement with BBC.

1. Direct Debits may only be initiated by individuals over the age of 18 years.
2. You are entering into a contract with BBC for a minimum period of 3 months ("Unlimited Boot Camp Sessions DIRECT DEBIT").
3. This contract will automatically renew for the same term after the anniversary date, unless the required notice period of 1 calendar month has been provided to cancel the contract.
4. Additional charges of up to £20.00 (per month) may be incurred for any unpaid Direct Debit.
5. For members paying by Direct Debit, missed sessions cannot be carried over to the subsequent month.
6. Direct Debits cannot be suspended and then reactivated to compensate for missed sessions.
7. Unpaid Direct Debits will be reclaimed within 30 days by Brownes Boot Camp.
8. The cancellation of your Direct Debit contract with BBC cannot be initiated for a minimum period of 3 months. When providing notice of cancellation after the minimum period of 3 months, one month's notice is required (the minimum term is therefore 3 months in total). Payments will continue to be collected until we are notified either in writing or by email of a member's wish to cancel their membership.
9. Notice of cancellation must be provided in writing and sent by email to membership@brownesbootcamp.co.uk. You will receive an email confirmation, which should be retained as proof of receipt of your notice of cancellation. Should you not have access to email, you are at liberty to provide written notification directly to your trainer at your next session. BBC will issue a written receipt, which should be retained by you as proof of receipt of your notice of cancellation. In the event that you cancel your Direct Debit before the minimum period of 3 months, you will be liable for full payment of the remaining period.
10. Unused sessions will not be refunded, and your contract will not terminate until your membership card has been returned to BBC and confirmed to you in writing.
11. Should you wish to freeze your contract, you may be eligible to do so under exceptional circumstances, to be reviewed on a case-by-case basis. This will be solely at the discretion of the Managing Director of BBC. Applications must be submitted in writing and sent by email to membership@brownesbootcamp.co.uk.
12. BBC reserves the right to adjust its membership tariffs at any time. Notification of such changes will be provided by BBC on their website 30 days prior to any pricing alterations. Notification will be displayed on the BBC website and disseminated via email communications to the member's registered address.

EXCLUSIONS:

1. All BBC trainers possess their own Public Liability Insurance, available upon request. Additionally, BBC holds its own Certificate of Employers' Liability Insurance, also available upon request. A list of trainer qualifications is accessible on the BBC website.
2. BBC reserves the right to utilize any individual and group photographs or video footage of you for promotional and media articles, press, or promotional purposes, authorization for which is displayed on our Members Forms.
3. I agree to utilize BBC facilities in accordance with these terms and conditions as published on the BBC website.
4. I attest that I have no medical or physical reason that would preclude my safe participation in an exercise program prescribed by BBC Instructors, and I do so entirely at my own risk.
5. I understand that Fees are payable as indicated above, irrespective of my attendance or non-attendance.
6. Where BBC members have purchased block sessions, these must be utilized within 2 months from the date of purchase. Under no circumstances will the 2-month period of validity be extended.
7. Brownes Boot Camp is registered with the ICO (Information Commissioner's Office). We are committed to processing your personal data in accordance with the provisions of the Data Protection Act 1998 (DPA) and are registered under the act.
8. BBC block cards are to remain in the name of one individual and cannot be transferred or used by any other member.
9. All BBC locations possess their own outdoor training permit from the local council.
10. BBC block cards will remain in the possession of Angus, who will sign off each time you attend.
